The following crime log includes ALL alleged criminal incidents reported to and made known to the Division of Public Safety. **The Division of Public Safety provides safety, security and patrol services for all areas comprising the Penn Patrol Zone, which includes 30th Street to 43rd Street, on the east-west border, and Market Street to Baltimore Avenue, on the north-south border, in addition to patrols provided by the Philadelphia Police Department.
